

Outbound Cargo to the U.S.

The following information is subject to change at any time and has been put together through discussions between Agape Flights Representatives & US Customs officials.

Information Agape Flights requires NO LATER THAN 0800 EAST COAST TIME 48 Hours PRIOR to a scheduled flight departure from Venice FL:

- 1) Missionary (last name/first name, agape account number/city – CAP, CAY, PAP, STI, DMG, GHB, etc.)
- 2) Number of packages and description of items in each package
- 3) Actual/Estimated weight (in pounds) of each package
- 4) Actual/Estimated value (US dollars) of each package
- 5) Date of flight you are requesting to send the package(s) back to the US
- 6) Consignee (last name/first name and mailing address of individual(s) who are receiving the package(s)
- 7) How you would like us to process the package – typically UPS or USPS. (This eliminates the need for a bill of lading.)

All the above information is now required by US Customs and Border Patrol and must be complete by the time stated above in order for Agape Flights to take possession of your packages. Packages that are not approved will be refused by the pilots since they can face up to a \$5,000 fine per infraction.

IMPORTANT

Once Agape Flights has received the required information & your package is approved, a 6-digit “Box Number” will be provided in order to identify each package. This “Box Number” is your confirmation that Agape Flights is expecting and will receive your package for transportation to the U.S. This “Box Number” will be used to complete the necessary U.S. Customs forms.

Is what I am sending back to the U.S. mail or cargo? (according to US Customs)

Mail is NOT: decided by weight or size.

Mail is NOT: decided by the intention of sending it through the US Postal Service once it arrives in the U.S. (even if it has stamps on it)

Mail IS: personal letters / newsletters / bill payments / thank-you cards / postcards, etc.

Mail IS: other written or printed materials **BUT NOT** professionally bound and/or published material (ie, books).

Cargo IS: CD's / DVD's(see note) / VHS Tapes / Cassette Tapes / Books / Undeveloped Film / Returned articles of Clothing / etc.

*DVD's from Netflix or other approved mail-order movie service IS considered mail.

Cargo IS: all other items not considered mail regardless of how small.

If there is a question whether something is considered mail or cargo, please ask an Agape Flights representative - but it most likely is cargo.

If I am sending out a package that is considered “cargo”, what paperwork do I need to complete and include with my package?

If you are ***NOT returning to the U.S.*** but are sending cargo back to family, friends, co-workers or as a gift: Please complete **CBP Form 7523**.

If you are returning a ***U.S.- products***: Please complete **CBP Form 3311**.

If you ***ARE returning to the US or already have returned*** and you are sending cargo back as personal effects and household goods: Please complete **CBP Form 3299**.

**An internet connection is REQUIRED to fully complete these forms with the required information.*

PAPERWORK TO BE COMPLETED AND ATTACHED TO OUTBOUND PACKAGES

- **MISSIONARIES MUST ATTACH TWO (2) CUSTOMS FORMS 7523, 3311 OR 3299**
- **YOU ONLY NEED TWO (2) IDENTICAL COPIES OF THE APPLICABLE CUSTOMS FORMS NO MATTER HOW MANY PACKAGES YOU ARE SENDING OUT AS LONG AS THE SAME PERSON IS RECEIVING THOSE PACKAGES. PLEASE LIST AND IDENTIFY THE PACKAGES ON THE FORM. PLEASE DO NOT ATTACH A SEPARATE FORM TO EACH PACKAGE.**
- **PLEASE BE SURE TO PROPERLY IDENTIFY EACH PACKAGE WITH ITS APPROPRIATE AGAPE FLIGHTS ISSUED "BOX NUMBER".**
